

## Notification of the Production and Importation of Hazardous Chemicals in Thailand

Part 132 of Chapter 41, Government gazette, February 19, 2015, B.E. 2558

The notification in relation to the manufacture or import of hazardous substances in the annex 5.6 of B.E. 2558 that the Department of Industrial Works (DIW) is responsible for.

Clause 1: In this notice,

**"Hazardous substances"** mean a hazardous material listed in the annex 5.6 of notice 2558 that the Department of Industrial Works (DIW) is responsible for. The definitions of hazardous substances are in accordance with the second paragraph of Article 18 of the Hazardous Substances Act 2535.

**"Substance"** means an element or compound that is naturally occurring or caused by various processes including additive necessary to preserve the stability of the substance or Impurities that occur in manufacturing process. But it does not include a solvent that can be separated from the substance.

**"Mixture"** means a mixture or substance containing a preparation of two kinds or more (not interacting with each other).

Clause 2. The **manufacturer or importer** of hazardous substances exceeding **1,000 kilograms per year** shall submit the notification under this paragraph. Notification shall be submitted only once via a computer network of the Department of Industrial Works (DIW) or other system as prescribed by the Ministry of Industry within **60 days** from the date of manufacture or importation of hazardous materials in quantities in excess of the stipulated quantity above.

The notice will be effective from the day following the date of publication in the Government Gazette.
